# ORDERING REPLACEMENT PARTS and SERVICE ASSISTANCE

The LITTELL line of coil handling and feeding equipment is custom engineered to fit the needs and requirements of each application. For this reason, the LITTELL serial number becomes the only way to properly identify your individual machine. This number allows LITTELL service engineers to locate a complete set of records that were originally used in the engineering and manufacture of each particular machine.


From these records, we are able to duplicate almost any part made for LITTELL coil handling equipment built in the past fifty years.

The LITTELL serial number is permanently stamped on the LITTELL machine nameplate or on the base of the machine itself.

It will appear as a five digit number followed by a dash and two more digits indicating the year in which the machine was shipped from the LITTELL factory.

When placing an order for replacement parts, please provide the following information:

- 1. The LITTELL serial number example: 79602-71
- 2. A good description of the part or parts required.
- 3. The LITTELL part number or service manual index number that has been assigned to the part.
- 4. The source of information from which you found the part illustrated or described. This may be a LITTELL drawing, a service bulletin number, or in some cases, the number is stamped directly on the part.
- 5. The quantity required.

In the absence of a good part number or description, we ask that you include either a sketch, drawing, or photograph to help us in identifying your needs. If this is not convenient, circle or point to the parts required on a drawing removed from your service manual and forward it with your order. The LITTELL Service Department will send you a new drawing to keep your service manual complete.
